### **SOLUTIONS**

1. (a) According to lens maker's formula

$$\frac{1}{f} = \left(\frac{\mu_g}{\mu_L} - 1\right) \left(\frac{1}{R_1} - \frac{1}{R_2}\right)$$

Where  $\mu_g$  is the refractive index of the material of the lens and  $\mu_L$  is the refractive index of the liquid in which lens is dipped.

As the biconvex lens dipped in a liquid acts as a plane sheet of glass, therefore

$$f = \infty \Rightarrow \frac{1}{f} = 0$$

$$\therefore \frac{\mu_g}{\mu_L} - 1 = 0 \text{ or } \mu_g = \mu_L$$

2. (a)

As the emergent ray emerges normally from the opposite face,

$$e = 0, r_2 = 0$$

$$As r_1 + r_2 = A \Rightarrow r_1 = A$$

Applying Snell's law for incident ray


$$\sin i = \mu \sin r_1 = \mu \sin A$$

Or 
$$\mu = \frac{\sin i}{\sin A}$$
 [Let  $i = i_1$ ]

For small angle,  $\sin i \approx I$ ,  $\sin A \approx A$ 

$$\therefore \quad \mu = \frac{i}{A} \quad \text{or } i = \mu A$$

$$= \frac{A+A}{2} = A (:: \delta_m = A \text{ (given)})$$

$$: i_{\min} = 0^0 \Rightarrow A_{\min} = 0^0$$



$$\mu = \frac{3}{2}$$

According to lens maker's formula

$$\frac{1}{f} = (\mu - 1) \left( \frac{1}{R_1} - \frac{1}{R_2} \right)$$

For biconvex lens,  $R_1 = +20$  cm,  $R_2 = -20$  cm

$$\therefore \frac{1}{f} = \left(\frac{3}{2} - 1\right) \left(\frac{1}{20} + \frac{1}{20}\right) = \frac{1}{20} \text{ or } f = 20 \text{ cm}$$

According to thin lens formula

$$\frac{1}{f} = \frac{1}{v} - \frac{1}{u}$$

Here, u = -30 cm

$$\therefore \frac{1}{20} = \frac{1}{v} - \frac{1}{-30} \Rightarrow \frac{1}{v} = \frac{1}{20} - \frac{1}{30}$$

$$v = 60 \text{ cm}$$


The image is formed at a distance of 60cm on the right hand side of the lens. It is a real image.

Magnification, 
$$m = \frac{v}{u} = \frac{h_I}{h_0}$$

$$\frac{60cm}{-30cm} = \frac{h_1}{2cm} \Rightarrow h_1 = -4cm$$

-ve sign shows that image is inverted.

The image is real, inverted and height of 4 cm as shown in figure.

$$\delta_1 + \delta_2 = 0$$

Intensity of image formed by lens is proportional to area exposed to incident light from object.

I.e. Intensity ∝ area

Or 
$$\frac{I_2}{I_1} = \frac{A_2}{A_1}$$

Initial area, 
$$A_1 = \pi \left(\frac{d}{2}\right)^2 = \frac{\pi d^2}{4}$$

After blocking, exposed area,

$$A_2 = \frac{\pi d^2}{4} - \frac{\pi (d/2)^2}{4}$$
$$= \frac{\pi d^2}{4} - \frac{\pi d^2}{16} = \frac{3\pi d^2}{16}$$

Hence, focal length of a lens = f, intensity of the image =  $\frac{3I}{4}$ 

13(c) Refractive index for medium  $M_1$  is

$$\mu_1 = \frac{c}{v_1} = \frac{3 \times 10^8}{1.5 \times 10^8} = 2$$

Refractive index for medium M2 is

where I = angle of incidence



1.

Sol: (a)

When white light is passes through a lens, violet light is more refracted than red light because wavelength of violet is less than red light and therefore focal length for red light is greater than violet.

2.

Sol: (a)

Microscope is an optical instrument which forms a magnified image of a small nearby object and thus, increases the visual angle subtended by the image at the eye so that the object is seen to be bigger and distinct. Therefore angular magnification for image is more than object.

3.

Sol: (b)

The sign of magnification depend on the sign convention chosen. According to the new Cartesian sign conventions, magnification for a convex mirror is positive because image formed by a convex mirror is always virtual and erect. A concave mirror can form virtual or erect images and also real, inverted images. In the latter case, its magnification becomes negative. The reason though correct does not explain the assertion properly.

4.

Sol: (b)

Let L is the distance between a real object and its real image formed by a convex lens, then as

$$L = (|u| + |v|)$$

$$= \left(\sqrt{u} - \sqrt{v}\right)^2 + 2\sqrt{uv}$$

L will be minimum when

$$\left(\sqrt{u} - \sqrt{v}\right)^2 = 0$$

i.e., 
$$u = v$$

Putting, u = -u and v = +u in lens

Formula

$$\frac{1}{v} - \frac{1}{u} = \frac{1}{F}$$

$$\frac{1}{u} - \frac{1}{-u} = \frac{1}{F}$$

$$\therefore (L)_{\min} = 2\sqrt{2F \times 2F} = 4F$$

Sol: (a)

The fringe width is given by

$$\beta = \frac{\lambda D}{d}$$

Here D is the separation between screen and slits and d is the separation between slits

6.

Sol: (c)

Lenses have different refractive index for different wavelengths of light. The refractive index decreases with increasing wavelength. So red light will bend least and violet the most. This will result is slight dispersion which will be seen as chromatic aberration.

7.

Sol: (b)

In telescope to have a large magnifying power, focal length of objective lens is kept large. To increase the magnifying power and resolving power, aperture of the objective lens is made large.
