NOTIFICATION

ENGAGEMENT OF CONTRACT MEDICAL PRACTITIONERS(Specialist/GDMO) ON FULL TIME CONTRACT BASIS ON ALIPURDUAR DIVISION , NORTHEAST FRONTIER RAILWAY.

In view of the existing workload and the exigencies related with the COVID-19 Global pandemic and in view of adequate preparedness, it has been decided to engage 'Contract Medical Practitioners(Specialist/GDMO) from open market on following terms and conditions :

1. Engagement of Specialist Doctor on contract against existing regular 01(one)post(IRHS) for a period of 1(one) year from the date of engagement which can be extended purely on Administrative requirement and willingness of Contract Doctor, or till the scheme is available, whichever is earlier.
2. Engagement of GDMOs (for 10 posts) over and above sanctioned posts, purely on temporary basis from the date of engagement to continue till 31/03/2022 or till Pandemic of Covid-19 is continues, which can be extended purely on Administrative requirement or till the scheme is available, whichever is earlier.

An interview through Whatsapp call will be conducted to engage Specialist/ GDMOs from open market. The details of the scheme are given below :-

No. OF VACANCIES (1+10)=11 : **01(UR)(Regular post)**—For Ophthalmologist against existing vacancy.
: **10(Ten) Temporary posts---**For General Duty Medical Officers(GDMO) -for Covid Quarantine facilities & Isolation Wards set up in APDJ Division . Since the posts are over & above sanctioned posts due to the exigencies on temporary measure, no prescribed category distribution (SC/ST/OBC) is applicable.

NB :

1. The vacancies may alter as per Administrative Requirement at any time during the engagement. There may be "Wait Listed/Stand By" candidates against the notified panel/select list who may be engaged as per necessity.
2. The Administration reserves the right to place the engaged GDMOs anywhere in the Jurisdiction of APDJ Division, N.F.Railway.

Educational Qualification/Eligibility :

- a) For **Specialist** – The candidate should be a minimum MBBS with Post Graduate Degree/Diploma in respective subject/field as a Specialist and should be recognized by the Indian Medical Council .
- b) For GDMO--The candidate should be a minimum MBBS pass Degree from an Institute recognized by the Indian Medical Council, or with a valid registration certificate of any of the State Medical Councils of India after completion of one year compulsory internship.

AGE :

- i) Candidate should not exceed 53 years of age as on 01.05.2021. However, age relaxation is admissible to the candidates belonging to SC/ST/OBC categories as per extant rules.
- ii) For retired Railway Doctors, retired Govt. Medical Doctors of Central & State Govt. age to be considered not exceeding 67 years as on 01.05.2021.

REMUNERATION :

For Specialist (Full time)	Rs.95,000 /-P.M.	The fee indicated against each is subject to the condition that no Govt. accommodation is provided. If Govt. accommodation is provided, and amount equivalent to the sum of HRA & License fee of the accommodation so provided will be deducted from monthly remuneration.
For General Duty Medical officer(GDMO)(Full time)	Rs.75,000 /-P.M.

****For retired Railway Doctors, Retired Govt. Medical Doctors of Central & State Govt, the monthly remuneration, as decided by Railway Board subject to the condition that the pension plus Contractual remuneration of retired Doctors should not exceed than the last pay drawn at the time of retirement. No Dearness allowances which are admissible to regular Railway employee shall be admissible.**


In the event of producing any wrong information/fake academic certificates / testimonials etc. the candidates will liable to be taken up under Gov. of Indian's law in force.

Selected candidates will be required to produce the original certificates, Pension Payment Order, Service certificate & Last pay certificate (in case of retired doctors) and attested photocopies of all certificates along with date of birth, EQ, Community, 4 copies of Pass port size recent photographs at the time of joining.

OTHER TERMS AND CONDITIONS

1. Selected candidates will be subjected to medical examination and only medically fit candidates will be engaged as GDMO.
2. The contract medical practitioner who enters contract with Railways will not have any claim or right for his/her continuity or automatic extension of the term of contract.
3. The contract shall liable to be terminated by giving 07 days notice by either side, without assigning any reasons, or if the Contract Medical Practitioner is mentally/physically incapacitated.
4. Engagement as CMP(GDMO) will not confer any right for automatic regularization or absorption in Railways.
5. The detailed instructions with regard to the duties while in contract in Railways shall be given to CMP concerned in the event of selection along with the offer of engagement.
6. Appearance in the interview will not vest any right upon the candidate to be engaged as CMP & no reasons will be cited or communication shall be made with the candidate in the event of candidate not getting selected.
7. The Railway Administration of the APDJ division, N.F.Railway reserves absolute right to cancel the notification without assigning any reason(s).
8. No Railway Privilege passes/PTOs shall be admissible to Retired Railway Doctors engaged as GDMO in his/her capacity of CMP. However, Duty passes as per eligibility would be provided for out station duties to the CMPs.
