**TERMS AND CONDITIONS:**

1. Qualification and Experience: As per NMC/MCI norms
2. Any change in date/time/mode would depend on status of pandemic.
3. Age limit not exceeding 67 years as on last date for receipt of application forms for all posts and categories.

9. No Private practice is allowed during the tenure of service in ESIC.
10. Candidates with eligibility of higher post (professor/associate professor) would be permitted to be interviewed against lower post (associate professor/assistant professor) and in event of selection, the candidate would be considered for placement with suitable upgradation of the lower post as per eligibility and recommendation of the selection board. The upgradation would be temporary and would be limited to tenure of the teaching faculty/appointment of regular faculty in the lower post.
11. Retirees from Central/State Govt/PSU from the equivalent posts are eligible to apply. Persons working in recognized/approved Private Medical Institutions fulfilling eligibility criteria for the post may also apply.
12. The candidates have to attach the self-attested copies of all the relevant certificates/testimonials for support of date of birth, category-sub-category, educational qualification, teaching experience, paper publications, Pension Payment Order (PPO), etc. with the application form and have to produce originals thereof at the time of interview.
13. The contract would initially be for a period of three years at the outset, with a provision of further extension for a period of two years. The maximum tenure of such engagement will not exceed 5 years or 70 years of the age of faculty, whichever is earlier.
14. Barring serious misconduct/irregularity, continuation of the incumbent would be based on satisfactory annual appraisal.
15. The contractual engagement can be terminated giving one month notice on either side.
16. The incumbent would serve the initial first year of contract, independent of regular faculty joining during this period. However, the contract would be terminable on one month notice, on joining of regular faculty in the subsequent years of contract.
17. Selected candidates will have to join immediately after receipt of offer of appointment (by Post/Email).

- (vi) Pension payment order (PPO), in case of retired employees from govt. organizations.
- (vii) Self attested copy of Community/Status Certificate in updated Government of India prescribed Format, Sub-category, in case of candidates belonging to SC/ST/OBC category. Candidates claiming reservation/age relaxation on the grounds of belonging to OBC category should submit the valid community certificate prescribed vide Govt. of India, Department of Personnel and Training O.M. No. 36012/22/93/Estt.(SCT) dated 15.11.1993 along with self declaration, failing which the benefit of reservation and age relaxation will not be given.
- (viii) Valid Income and asset certificate to be produced by Economically Weaker Sections duly certified by the competent authority as prescribed vide Govt. of India, Ministry of Personnel, Public Grievances & Pensions, DOPT office Memorandum No. 36039/1/2019-Estt.(Res) dated 31.01.2019. EWS certificate must be valid for year 2021-22.
- (ix) Certificate issued by competent medical board in respect of Persons with Disabilities.
- (x) NOC if candidates is employed in Govt./Semi Govt. /Autonomous bodies etc. from the employer.


- (a) Applications received after the due date will not be considered in view of ongoing COVID-19 pandemic in an attempt to curb the untoward exposure due to crowding.
- (b) The application and the other documents should be arranged in the above mentioned order one below the other preferably in PDF format. Hard copies of the above said document need to be submitted and verified at the time of interview.
- (c) If any candidate wishes to apply for more than one post, he/she must apply with separate sets of application forms, documents and testimonials, photographs, and separate demand draft fees for each post applied for.



- (d) Crucial date for determining the age limit and other eligibility criteria shall be the closing date for receipt of applications from candidates in India.
- (e) Mere submission of application does not confer any right to the candidate for being called for interview.
- (f) Incomplete or unsigned applications or the applications received after the due date of receipt of applications will summarily be rejected without any communication to the candidate.
- (g) Wrong declarations/submission of false information or any other action contrary to law shall lead to cancellation of the candidature at any stage. Opportunity of Interview given to candidates will be on provisional basis.
- (h) Before applying for the post the candidate should ensure that he / she fulfils the eligibility criteria mentioned above. The ESIC Dental College would be free to reject any application at any stage of selection process if the candidate is found ineligible for the post for which he/she has applied.
- (i) Canvassing in any form will be disqualification.
- (j) Disqualification – No person:-  
I.who has entered into or contracted a marriage with a person having a spouse living; OR  
II.Who, having a spouse living, has entered into or contracted a marriage with any person; shall be eligible for appointment to the said posts.  
III.Provided that the Director General may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this Regulation.
- (k) No TA/DA is admissible for attending the interview.
- (l) The contractual engagement may be terminated / discontinued on either side giving one month prior notice to this effect without assigning reason.
