B. TECH. PROGRAMME

B. Tech. programme in Food Technology & Management

Four years regular leading to the development of Techno-Managers for the food industries

Eligibility:- Candidate who have passed their class 12th exam and should have qualified in JEE (Main)–2021

Selection Process: Admission through Central Counseling conducted by CSAB. Updates on CSAB website (www.csab.nic.in) may be followed.

Total number of seats: 189

Ph.D. PROGRAMME

Ph.D. programme in following areas:-

1. Agriculture & Environmental Sciences, 2. Basic & Applied Sciences, 3. Food Engineering, 4. Food Business Management & Entrepreneurship Development, 5. Food Science & Technology

Eligibility:- Master degree in relevant discipline with at least 55% marks. (50% in case of SC/ST/OBC-NCL/Differently abled category)

Selection Process: NET JRF-Qualified/Research Entrance Test followed by Interview at NIFTEM. Candidate can apply only in one department. CSIR-UGC JRF or any other JRF holders are exempted from entrance test but need to appear in interview.

Total number of seats: - 33

M. TECH. PROGRAMME

M. Tech. Programme in following areas:

1. Food Technology and Management 2. Food Process Engineering and Management

5. Food Plant Operations Management

Course Duration: Two years regular

Eligibility: - Four Years Bachelor's Degree or Master's Degree in relevant discipline with minimum 60% marks in aggregate (55% in case of SC/ST).

Selection Process:- Based on valid GATE score/NIFTEM Entrance test for Non GATE.

Total number of seats: - 18 in each M. Tech. programme

MBA PROGRAMME

MBA Programme with Dual specialization in following areas:

1. Food & Agri Business Management (Compulsory)
2. One of Marketing/ Finance/ International Business

Eligibility: Bachelor's degree and equivalent in relevant discipline with minimum 50% aggregate marks (45% in case of SC/ST) or equivalent CGPA.

Selection Process: Last two years' CAT/MAT Score and an internal test for non CAT/MAT applicants followed by GD/PI

Total number of seats: 32

RESERVATION: Due reservation is given to EWS/OBC(NCL)/SC/ST/Physically challenged and Kashmiri migrants candidates as per Government of India Norms, provided they clearly mention their category in application form.
