5. The Blind, Physically Disabled, Deaf & Dumb students (who have 40% of minimum Disability) need not to pay Examination Fee as per O.U Order No. 1555/228/2007-08/Budget-V, dated: 25-03-2008 and also processing fee. A Xerox Copy of Medical Certificate must be attached to the EAF.

6. a) THE REGULAR CANDIDATES OF I & III-SEMESTER SHOULD SUBMIT THEIR EXAMINATION FORMS THROUGH ONLINE ONLY.

- b) The College will be held responsible for any mistake committed while filling the candidate name, father name, mother name and paper title (Theory, Practicals and Paper-wise marks) through ONLINE. IN CASE OF ANY MISTAKE Rs.1000/- will be levied as FINE for rectification of each error.

Fresh candidates appearing for I-Semester shall enclose xerox copies of their qualifying Degree Certificates (i.e. Provisional & Convocation certificates) duly attested by the Principal of College concerned. The other University candidates should enclose their Original Migration Certificate together with a fee of Rs.250/- in addition to the examination fee.

4. No Dues Certificate and Affiliation extension order for the year **2021-22** with sanctioned strength issued by the Academic Branch, O.U.
5. The clearance certificate from the Director, Directorate of Academic Audit, O.U.
6. The Clearance certificate from Nodal Officer, Statistical Cell, O.U.

9. The Principals are requested to remit the Examination fee in any branch of **State Bank of India** in favour of the Registrar, Examination Fee fund, O.U. A/C No.52198262033 and obtain a receipt from the Bank and submit the same to the Examination Branch along with EAF.
