Information and Instructions to the Candidates

1. Application Number generated during the submission of the application online is the Registration Number. This number should be quoted in all the enclosures and for all correspondence.
2. **Allocation of Seats**

***Priority will be given to EWS Candidate. In the absence of eligible EWS Candidate, the seat will be filled by UR Candidate.**

#Priority will be given to SC Candidate. In the absence of eligible SC Candidate, the seat will be filled by ST Candidate.

3. **Eligibility**

Applicant should be a citizen of India and should have studied class VIII onwards in the state other than TamilNadu. A certificate of Permanent residence in the format given in **Annexure-I** should be furnished (English version only will be accepted).

The minimum academic requirement is that the candidate must have passed in final examination of 10+2 (Class XII) or its equivalent recognized by any State Board / Central Board or any other Board (other than Tamil Nadu) accepted by Anna University, Chennai. The candidates must have studied Mathematics, Physics and Chemistry as compulsory subjects.

4. **Mode of Selection:**

The selection of candidates will be on the basis of **JEE(Main) 2024 All India Rank**.

5. **Online Counselling**

The Counselling for admission for the academic year 2024-25 will be conducted only through Online mode. Candidates will be called for Online counselling in the order of their merit. Mere attending the Online counselling will not confer any right/claim implicit or explicit for any candidate for claiming admission. Based on the merit and communal reservation, allotment will be made. **The candidates shortlisted for Online counselling will be notified in our website on 09.08.2024.**

The candidate must be ready with the details such as Marks (subject-wise), Percentage of Marks, Certificates, Year of Passing, Board / Institute, Scanned image of their photograph and signature. Scanned copy of Mark sheet / Transfer Certificate / Migration Certificate / Permanent Residence Certificate and Community Certificate for EWS/ OBC(NCL) /SC/ ST (if applicable), Rank card of JEE(Main) 2024 issued by CBSE (downloaded rank card is acceptable), Aadhaar card and other relevant certificates if any, before applying online.

Candidates are advised to send the scanned copies of relevant documents (as single pdf file) mentioned below to btechadmn@cecni.res.in with Application Number (generated during online submission of application):

- Mark Sheets (10th, 11th, & 12th)
- Transfer Certificate
- Migration Certificate
- Permanent Residence Certificate
- Community Certificate for SC/ST & OBC(NCL) & EWS
- Rank Card of JEE(Main) 2024
- Aadhaar Card

All the Original Certificates including Mark sheets and Permanent Residence Certificate will be verified and hence care should be taken while sending the scanned copies of the certificates.

Documents other than in English language should be translated by a competent authority and sent (both original version and translated English version) accordingly.

Application without any one of the relevant certificates or mark sheet will be rejected.

6. Procedure for submission of Application Form

The candidates shall apply only through online by logging on to www.cecni.res.in. The candidates should fill-up online application form and ensure that the application is complete and correct in all aspects before submitting the form. Once the application is submitted, it cannot be modified. Candidates are required to upload their photograph (less than 80 KB) and signature (less than 50 KB). **Online application without photograph and signature will be rejected. The candidates need not send the hardcopy of the online application or any other documents. Applications received other than the Online mode will be rejected.**

7. Application Fee:

Candidates are required to remit/pay application fee (non-refundable, Rs. 500/- for UR, EWS, OBC(NCL) candidates and Rs.250/-for SC/ST candidates) through online mode viz. RTGS/ NEFT/ IMPS/Debit Card/ Credit Card, etc to the following account and fill up the transaction details in the prescribed columns of online application. **No other mode of payment will be accepted.**

8.1 Note:

- If the original certificates are not in Hindi/English, duly certified translated version of Hindi/ English of such certificates will be required at the time of admission.
- Certificate of category of EWS/ OBC (central list) if applicable, is to be issued by the competent authority in the prescribed format and should clearly mention that the candidate belongs to EWS/ OBC(Non Creamy Layer). The certificate should have been issued on or after 1st April, 2024.
- Category Certificate issued prior to 1stApril, 2024 shall not be accepted in any case.
- Certificate of category of SC/ST (if applicable) is to be issued by the competent authority in the prescribed format.

8.2 The candidates are informed that admission given at the time of Online counselling is only provisional. In accordance with rules prescribed for admission, if they are found to be ineligible on actual verification of original certificates / particulars by the CSIR-CECRI/ DOTE/ Anna University, they cannot claim any right for admission or continuation of study at any stage.

Further, the confirmation of admission is subject to verification of marks / certificates by the authorities. If the mark sheet is found to be not a genuine one,

(i) Admission is liable for cancellation at any stage of study.

(ii) The candidate will be debarred from pursuing any course of study for a period of 3 years.

(iii) Legal action will be taken against the candidate for furnishing forged documents.

1. The Original Certificate should be signed by the Officer of the Revenue Department not below the rank of a Tahsildar in the District concerned or by the Block Development Officer–Cum–Panchayat Union Commissioner in the Block concerned.
2. The certificates should bear the stamp of the office of the Officer signing the certificate. The certifying officer should insist upon clear proof of the permanent residence of the parent or guardian of the candidate and satisfy himself of the genuineness of the residential qualification.
3. The State of Permanent Residence of a candidate's guardian will be taken into account only if both the parents of the candidate are not alive. The relationship of the guardian to the candidate should also be mentioned. If both the parents are alive, only the State of Permanent Residence of father should be taken into account.
