GENERAL CONDITIONS

- 1. All the posts carry usual allowances as admissible to Central Government Employees of similar status at Gorakhpur, Uttar Pradesh.
- 2. <u>Application Process:</u> The aspiring applicants satisfying the eligibility criteria in all respect can submit their application only through <u>Offline</u> mode. The applications in respect of above said posts along-with other relevant information will be available on official website of AIIMS Gorakhpur i.e. <u>http://www.aiimsgorakhpur.edu.in</u>
- 3. Last date of receiving of hard copy of completed application form in Recruitment Cell, AIIMS, Gorakhpur shall be 30th day from date of notification on official website of institute (<u>www.aiimsgorakhpur.edu.in</u>).
- 4. The applicants should check their eligibility for the post applied for. They must be fulfilling eligibility criteria as on the closing date of applications failing which their application will be rejected.
- 5. In case a candidate wishes to apply for more than one post, he/she is required to fill the form separately for each post.
- 6. The candidates have to send signed copy of offline application form along with self-attested copies of certificates/documents in support of fulfilling the essential criteria of age, educational qualification, teaching/research experiences etc, in support of their candidature. The Experience Certificate should clearly mention the period of experience, duration of experience ("from" to "to"), nature of experience (either teaching or research) etc. Candidates can only mention those teaching experiences which are recognized by (NMC/MCI/OCI/Govt. of India.

Age relaxation to these categories will be applicable as per the DoPT instructions.

Maximum age limit for applying for the aforesaid posts on deputation is 58 years for Professor & 56 years for Additional Professor/ Associate Professor/ Assistant Professor as on last date of receipt of application.

Retired Faculty from Institutes of National Importance (INIs) and Government Medical College (GMCs) at the level of Professor, Additional Professor and Associate Professor/ up to age of 70 years are eligible for applying on contract basis.

- 10. Candidates applying under any of the reserved category posts, viz. SC/ST/OBC/PwBD/EWS will be considered subjected to Caste/Disability/EWS Certificate issued by the appropriate/Competent Authority on the prescribed format. Community should be clearly and legibly mentioned in the Certificate.
- 11. Applicants applying for the posts reserved for OBC must obtain certificate of OBC (non- creamy layer) in the prescribed form issued by Competent Authority. The certificate should be of the current financial year, in accordance with instructions issued by the government of India in this respect from time to time. Applicants should as certain that they belong to the reserved categories (caste) enlisted in the Central List for the Other Backward Classes. OBC candidate(s) should not belongs to Creamy Layer and their sub-caste should match with the entries in Central List of OBC, failing which their candidatures will not be considered under any of the applied reserved category post(s). - 12. Only such persons would be eligible for reservation under PwBD quota in service/posts who suffer from not less than 40% of physical disability. - 13. The candidates are to satisfy all eligibility criteria before Offline application. They must possess the educational qualification and experiences as recognized by the Govt. of India. Their candidature will be cancelled at any stage if it is found that their educational qualification or experiences is not recognized by the Govt. of India.
