ELIGIBILITY

First Class Master's or Post Graduate Diploma (2 years) in any discipline and a three-year Bachelor's degree with at least 50% marks in the aggregate;

OR

CA with minimum 50% marks or CS/CMA with minimum 55% marks, with B.com degree;

OR

B.Tech/4 years degree with 6.5 CGPA or equivalent.

Non-engineering applicants who have undergone 10+2+5 years will be considered eligible to apply for the Doctoral Programme.

In addition, the applicant must have obtained a minimum of 50% marks in the aggregate in either the Secondary or the Higher Secondary Examination of a Board (or equivalent).

Reservation: Government of India guidelines for reservation are followed during admissions.

Applicants for the Doctoral Programme are required to submit CAT or other scores in lieu of CAT as specified below (the test score(s) should be valid on January 30th, 2025):

*Validity of score (other than CAT) - Two years from the date of the test and should be valid on the deadline of submission of the application form.

#Online GMAT/GRE (Take home) exam scores are not valid. Only test center-based GMAT/GRE scores are valid. Candidates should get their GMAT scores officially reported to the Institute using the code: 9CP-HT-94, and GRE scores officially reported to the Institute using the code: 7496.

HOW TO APPLY

A candidate can apply to a maximum of two areas of specialization. The SC/ST/OBC/EWS/PWD applicant (submitting attested copy of SC/ST/OBC/EWS/PWD certificate) are required to pay application fee of Rs. 1000/-, and all other applicants are required to pay an application fee of Rs. 2000/-. Applications will be received from November 01st, 2024 to January 30th, 2025.
